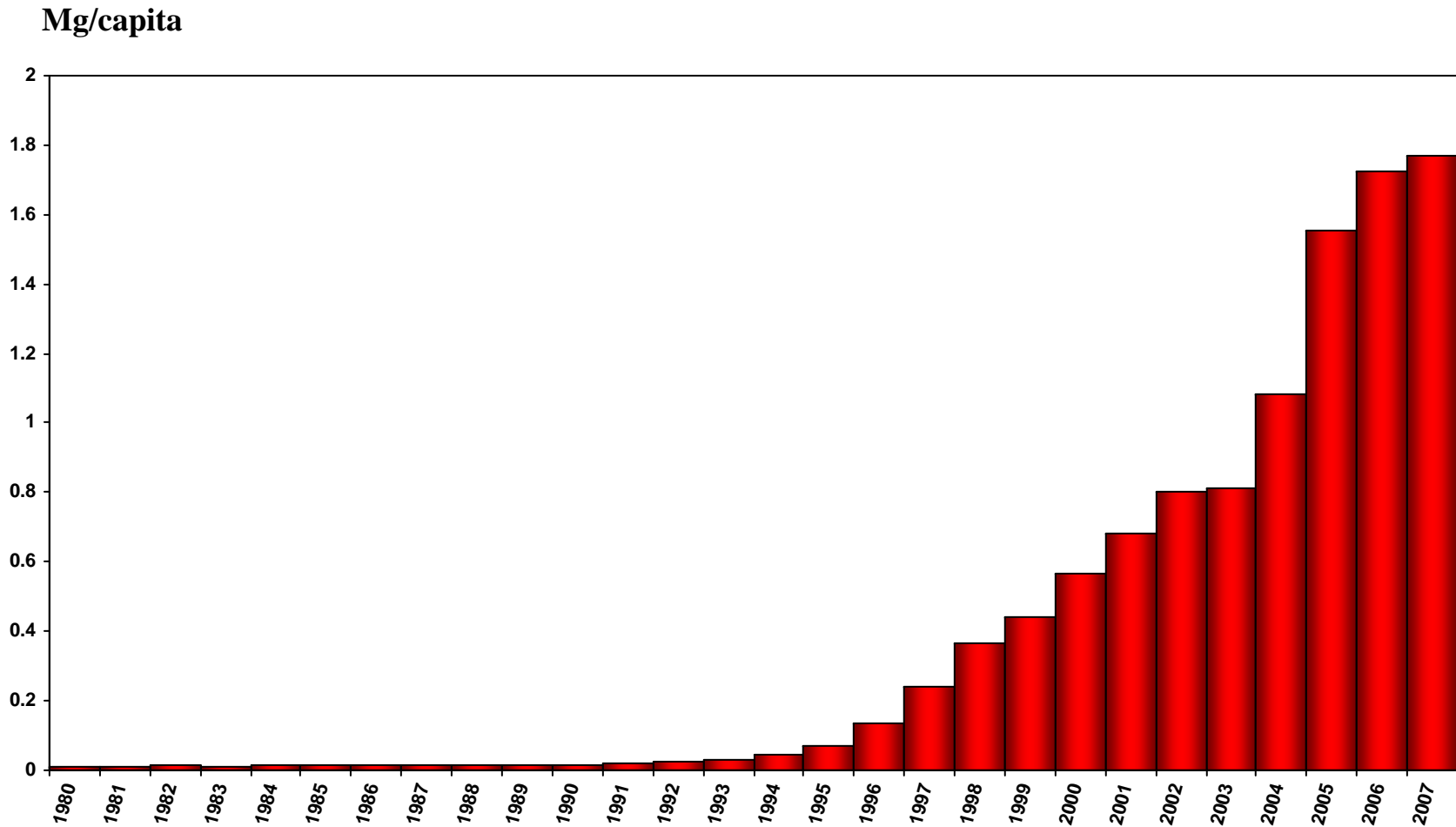
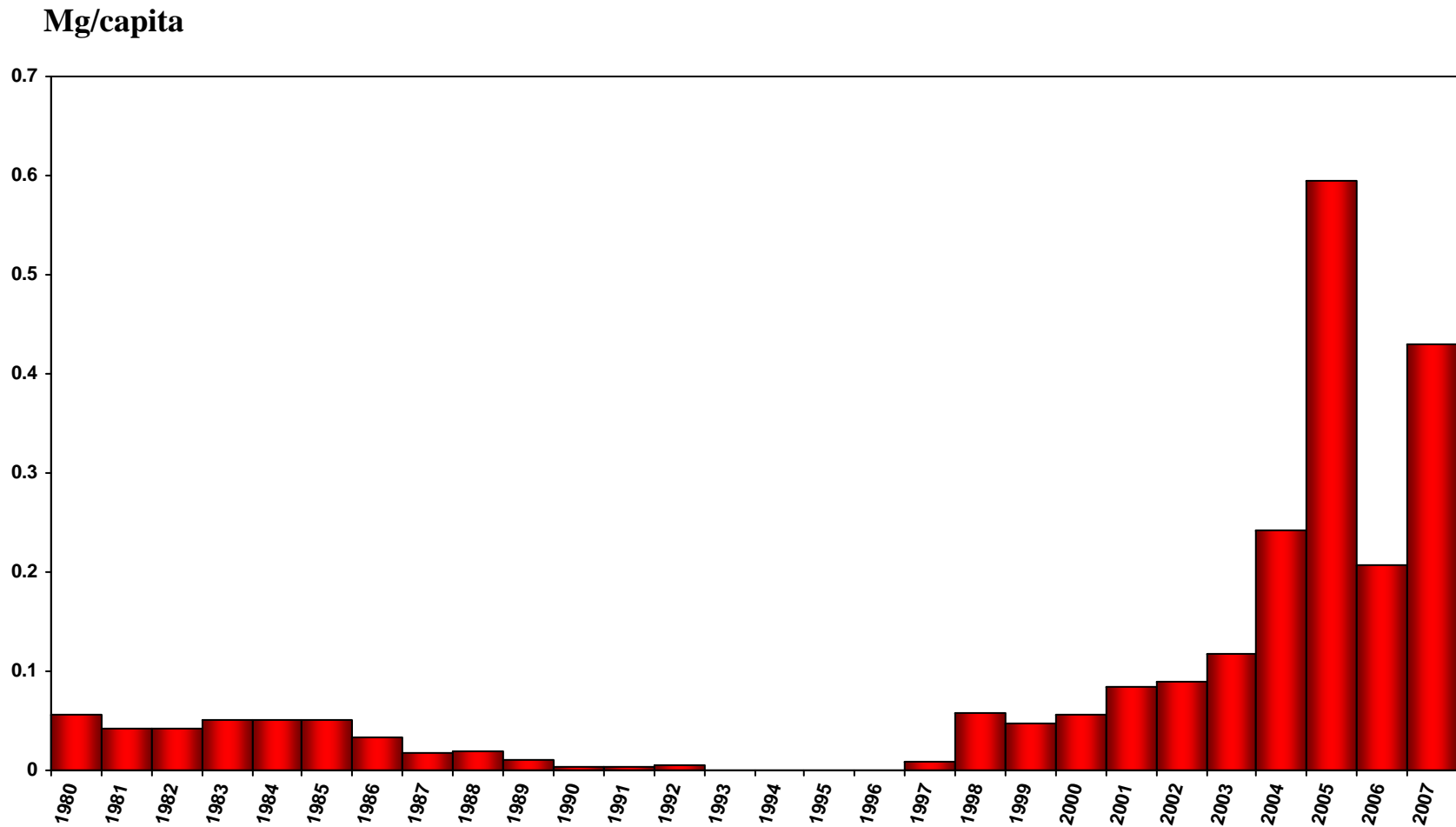


# Mg/capita Consumption of Fentanyl, Denmark, 1980-2007



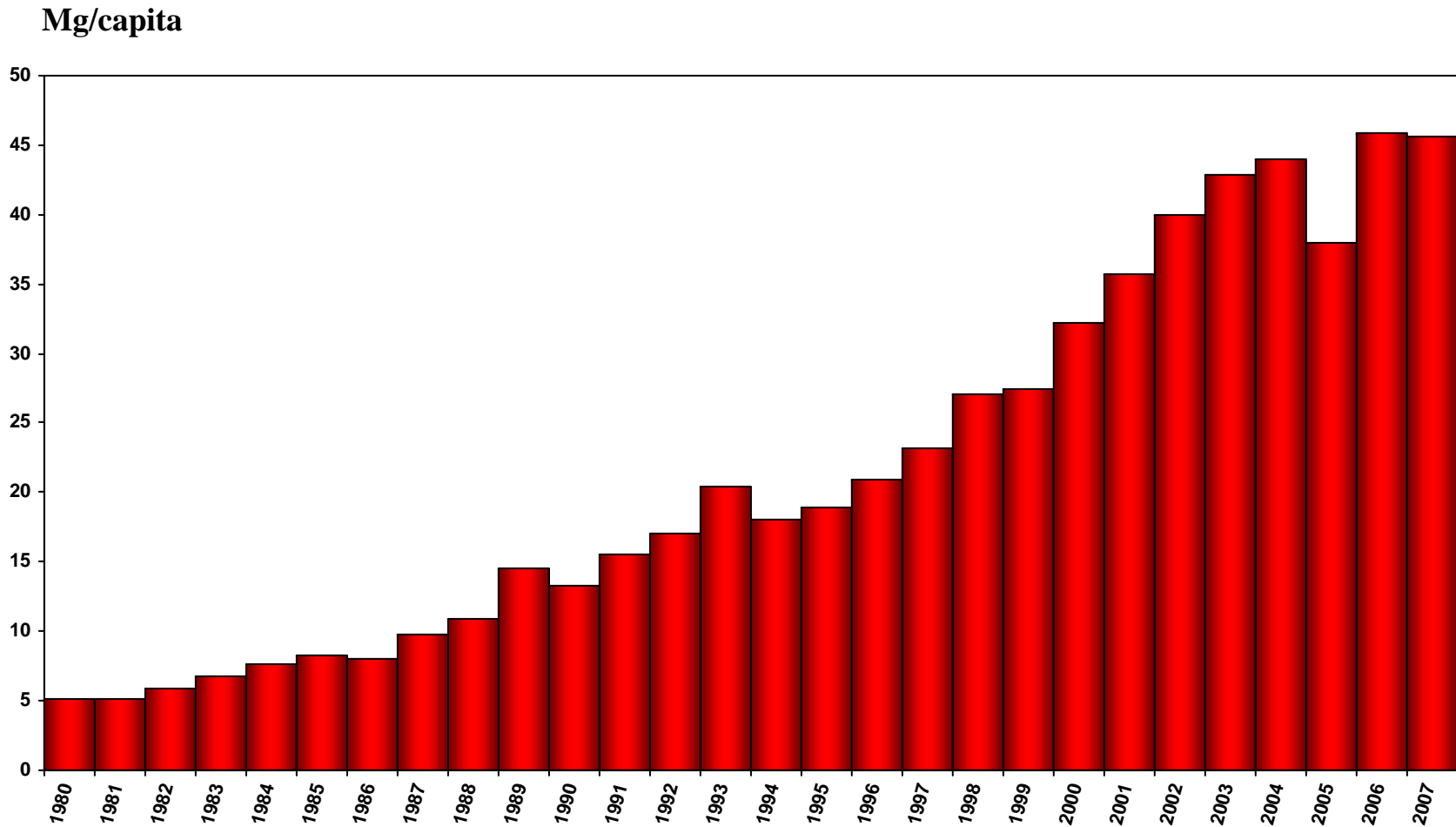

# Mg/capita Consumption of Hydromorphone, Denmark, 1980-2007



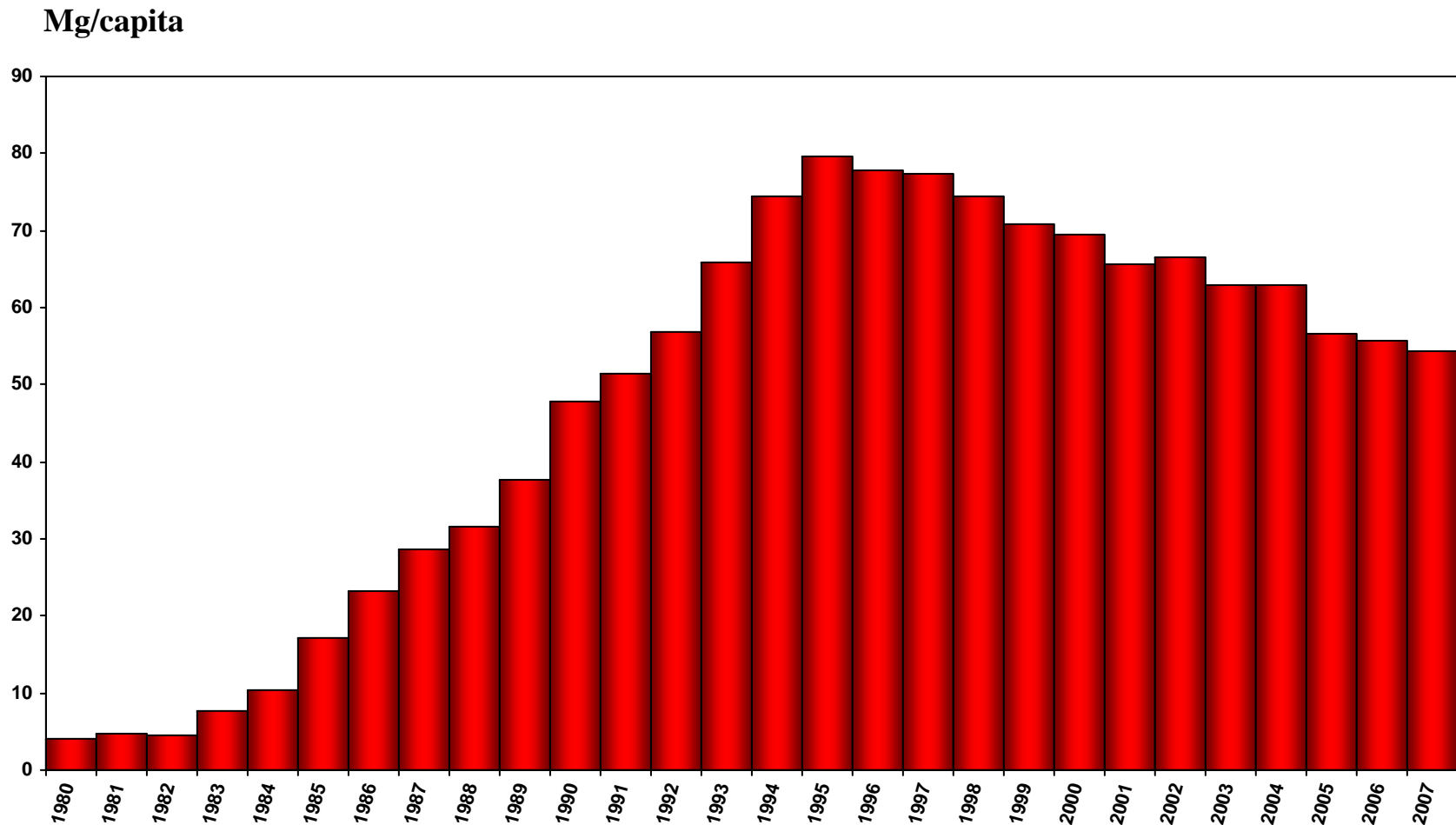

# Mg/capita Consumption of Methadone, Denmark, 1980-2007



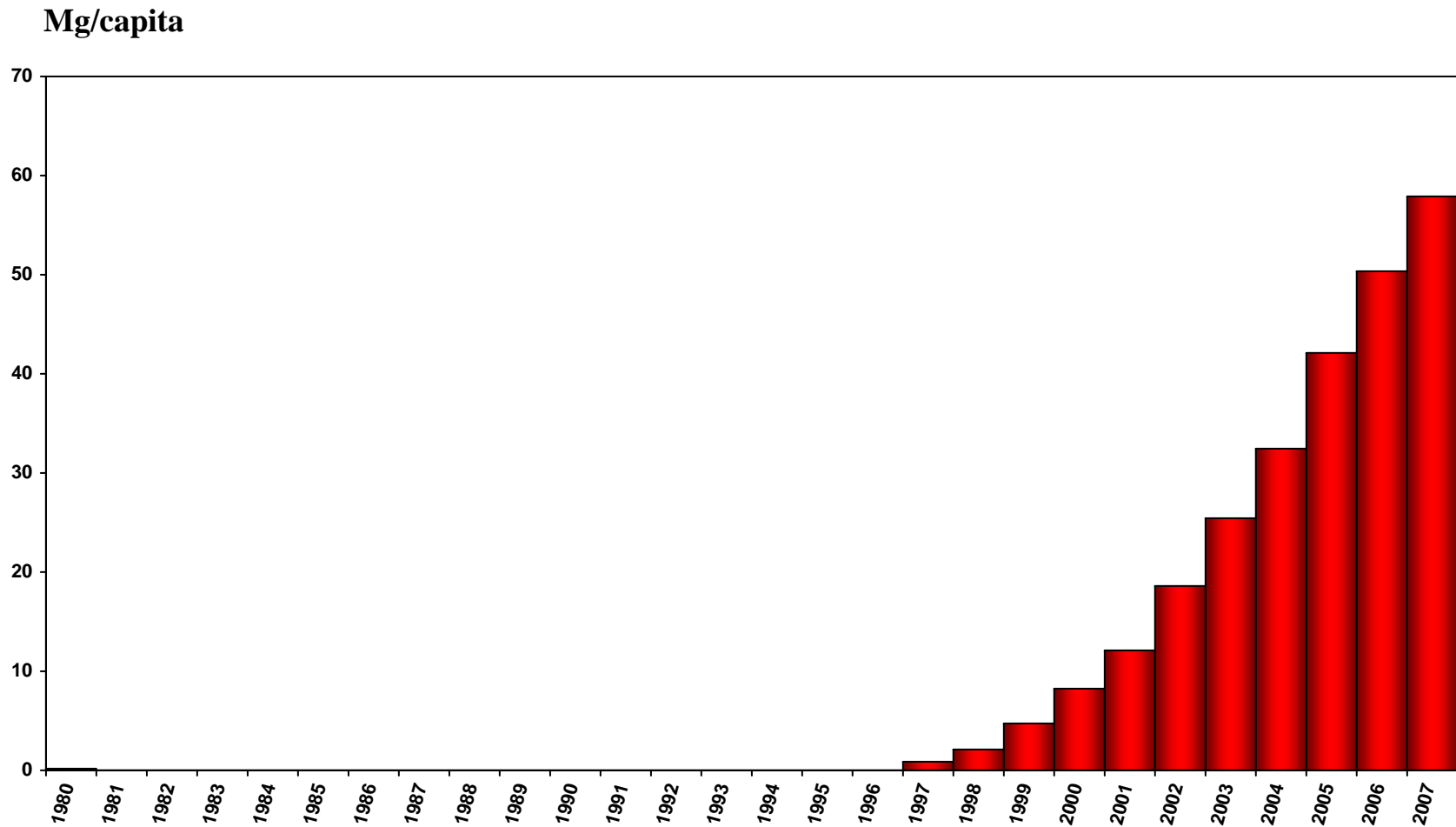

# Mg/capita Consumption of Morphine, Denmark, 1980-2007



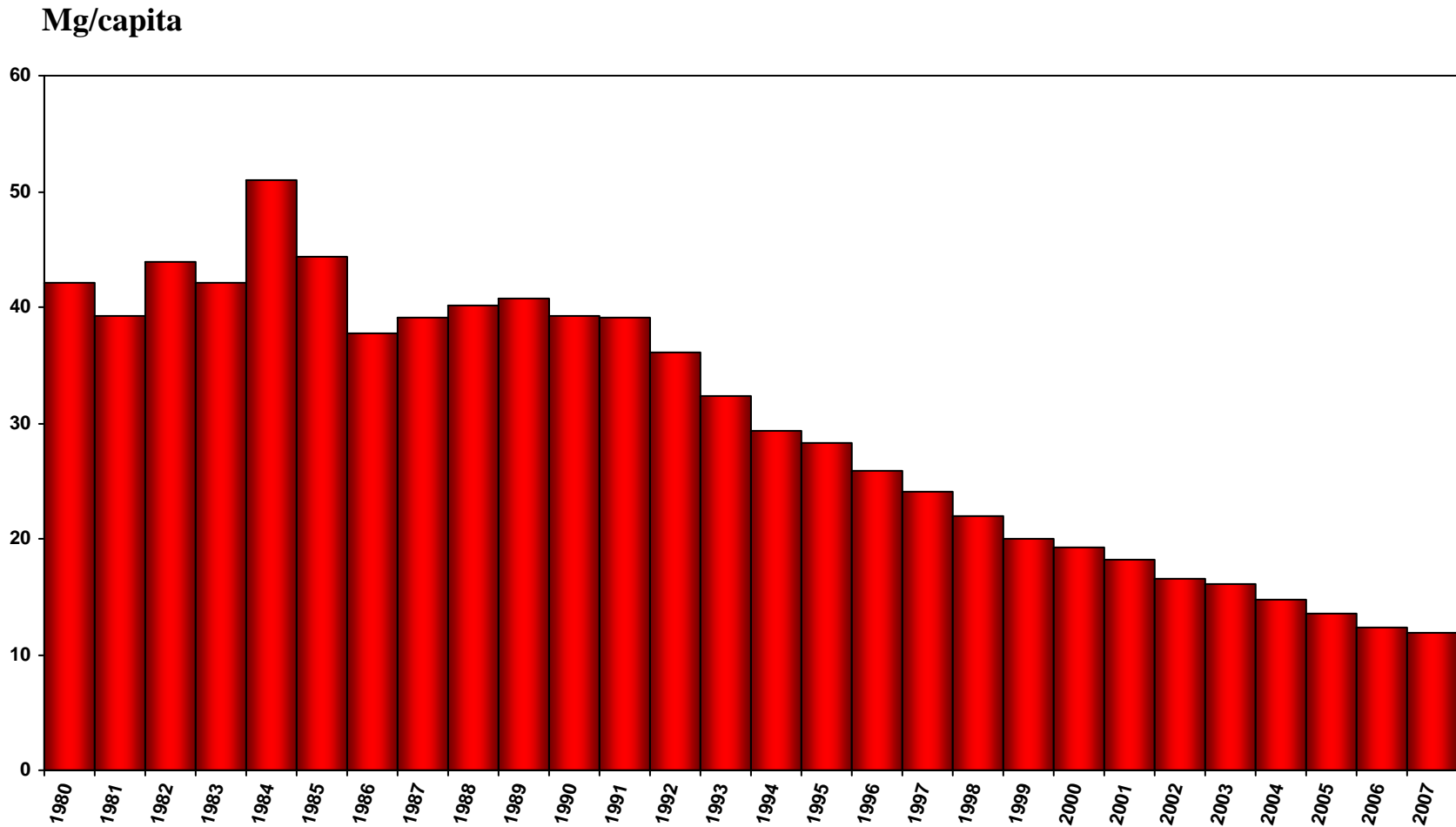

# Mg/capita Consumption of Oxycodone, Denmark, 1980-2007



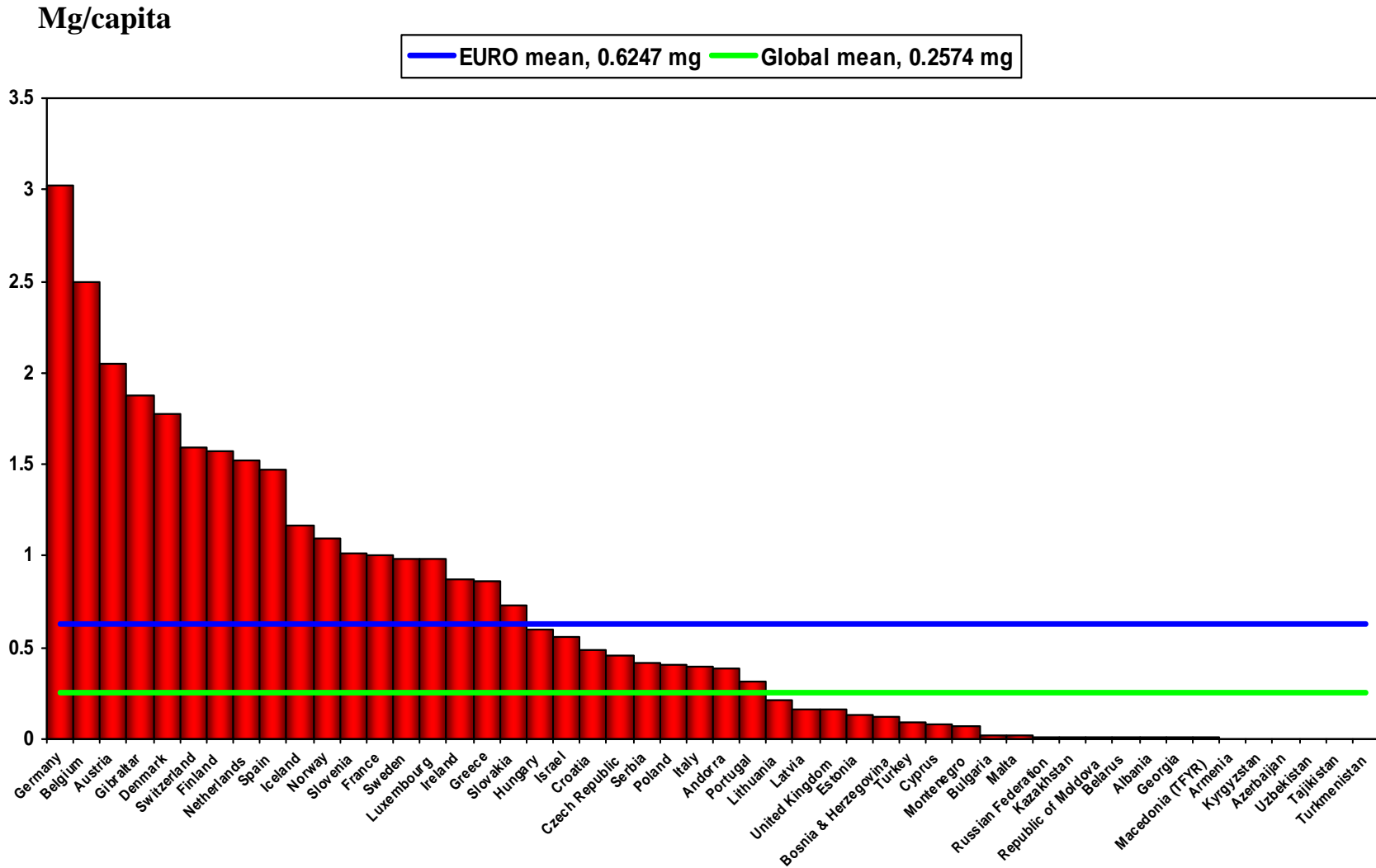

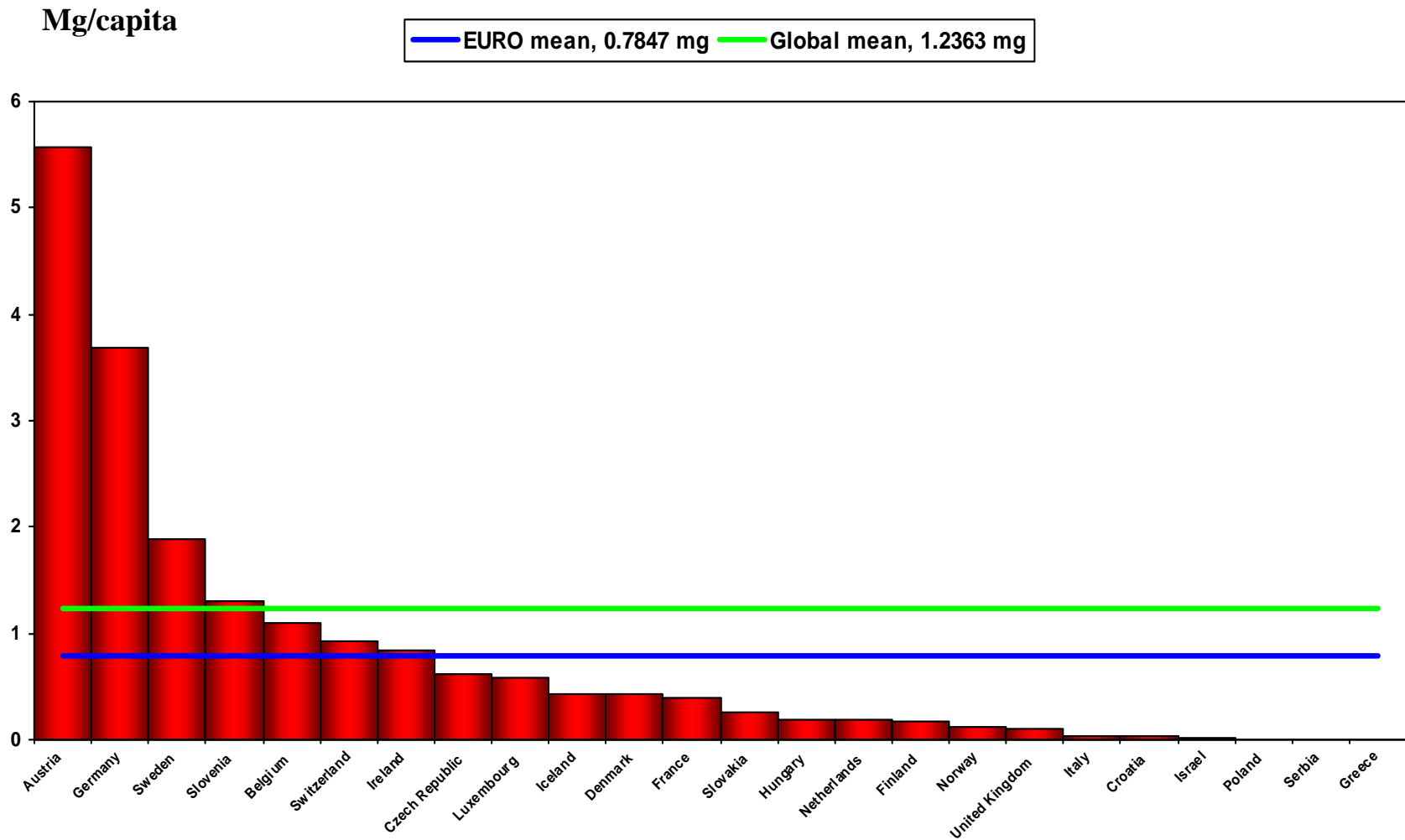

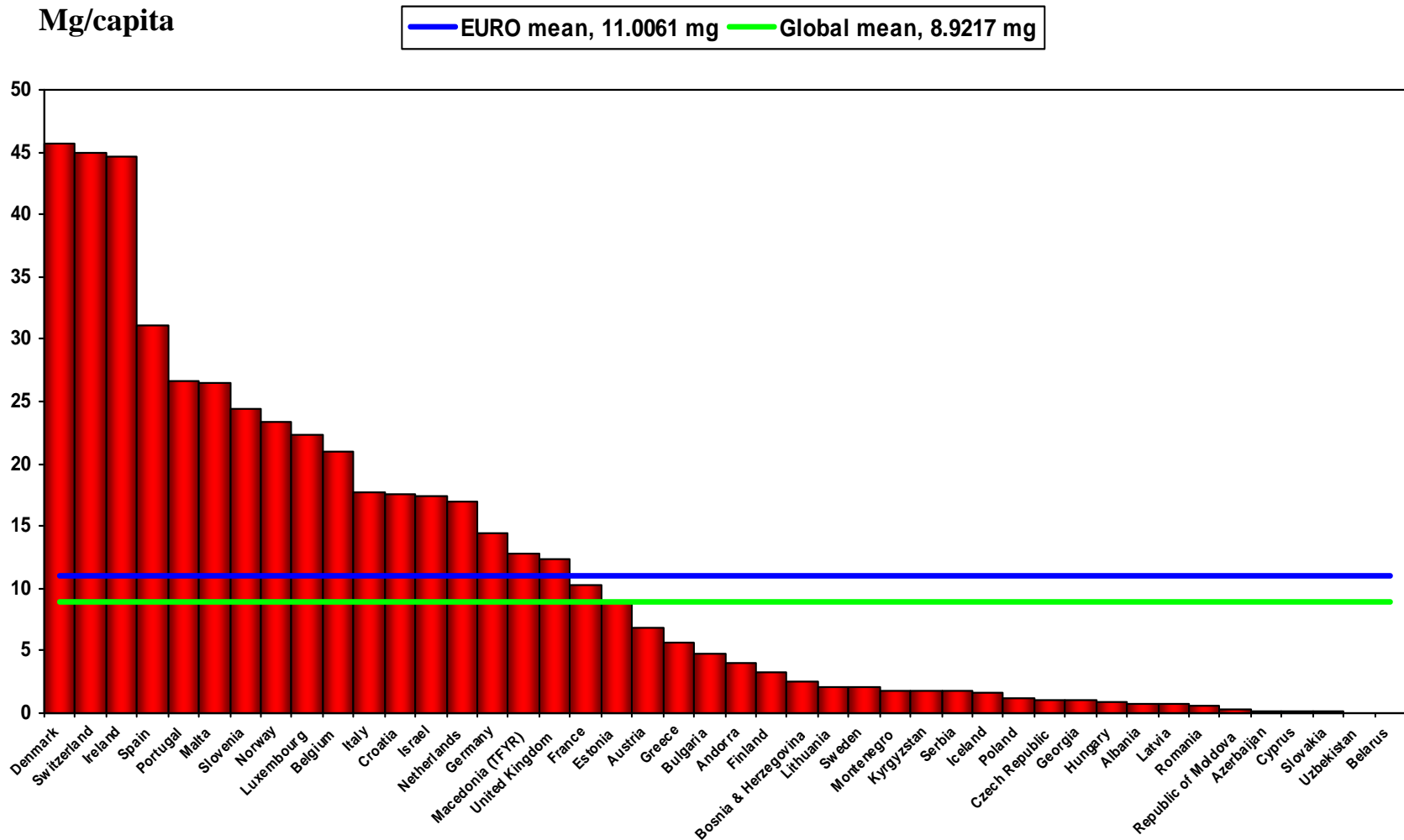

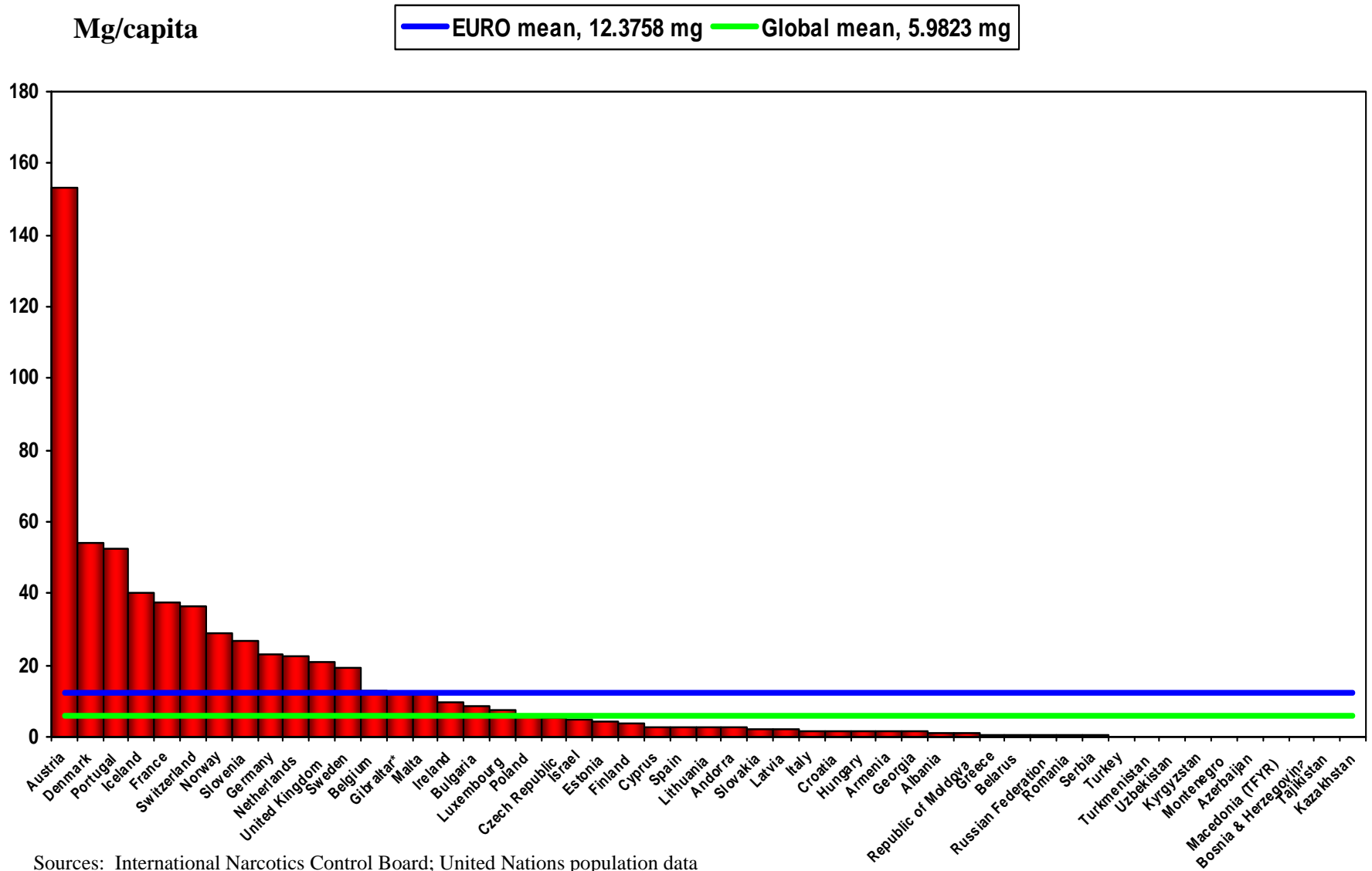

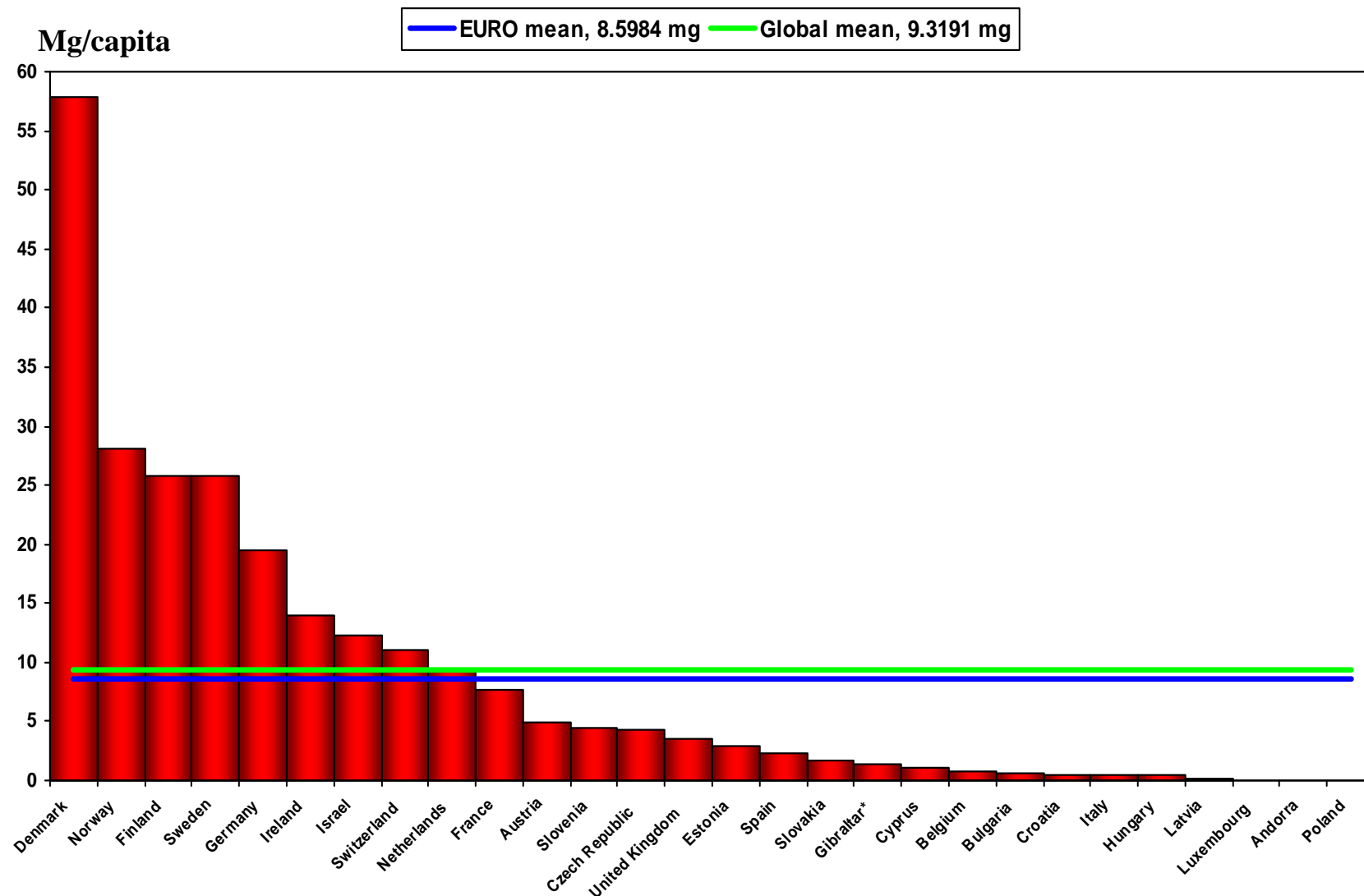

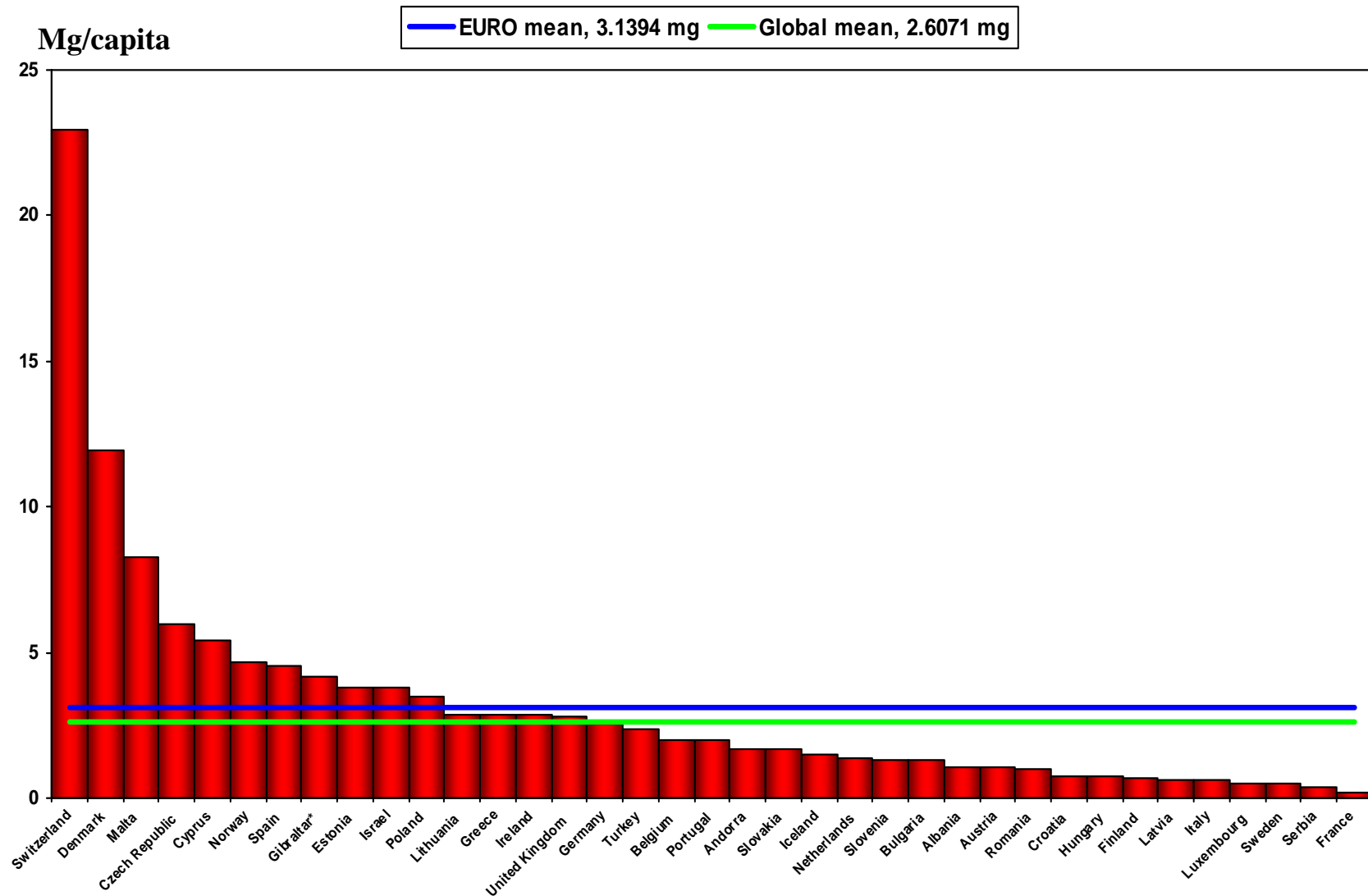

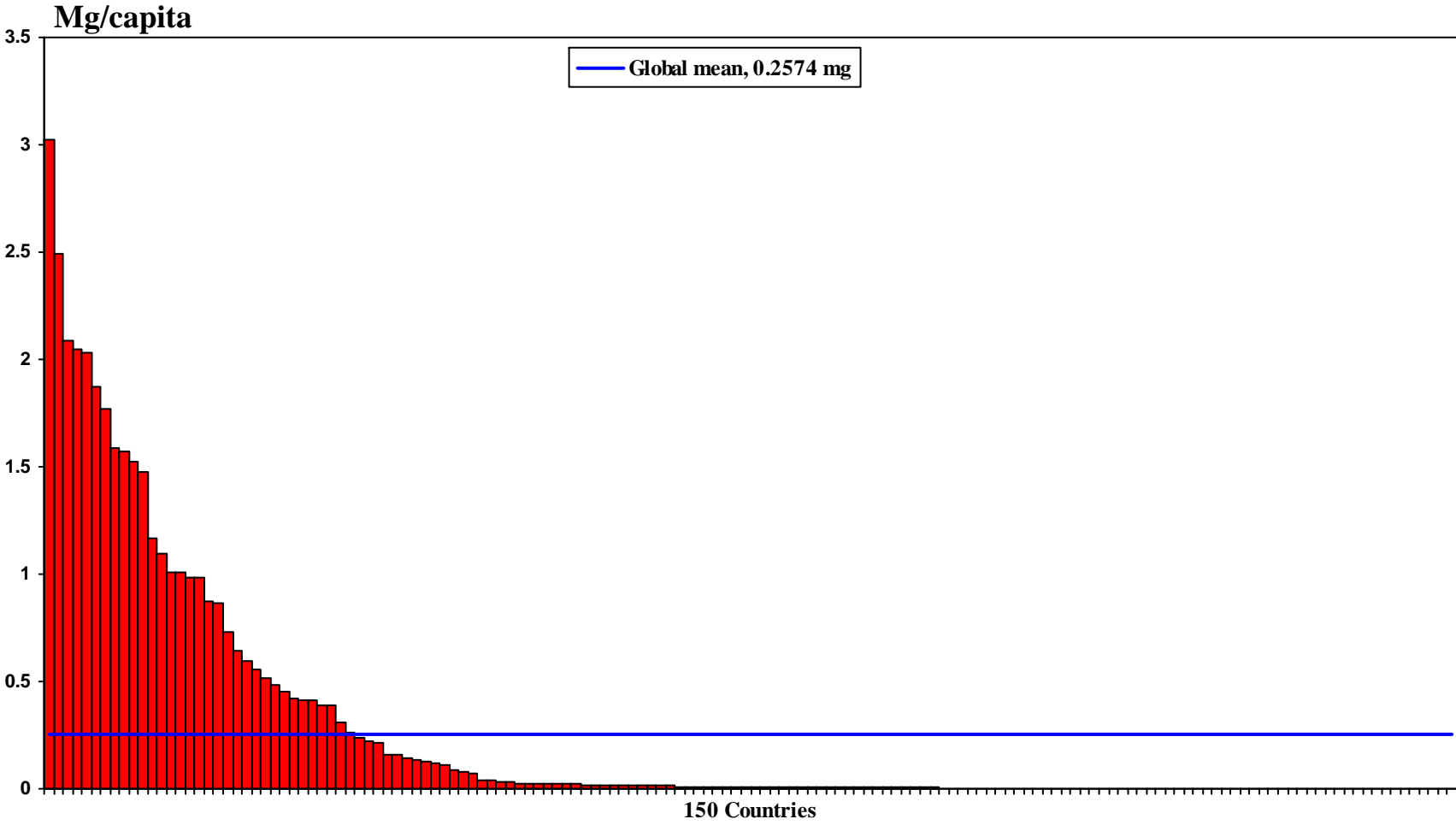

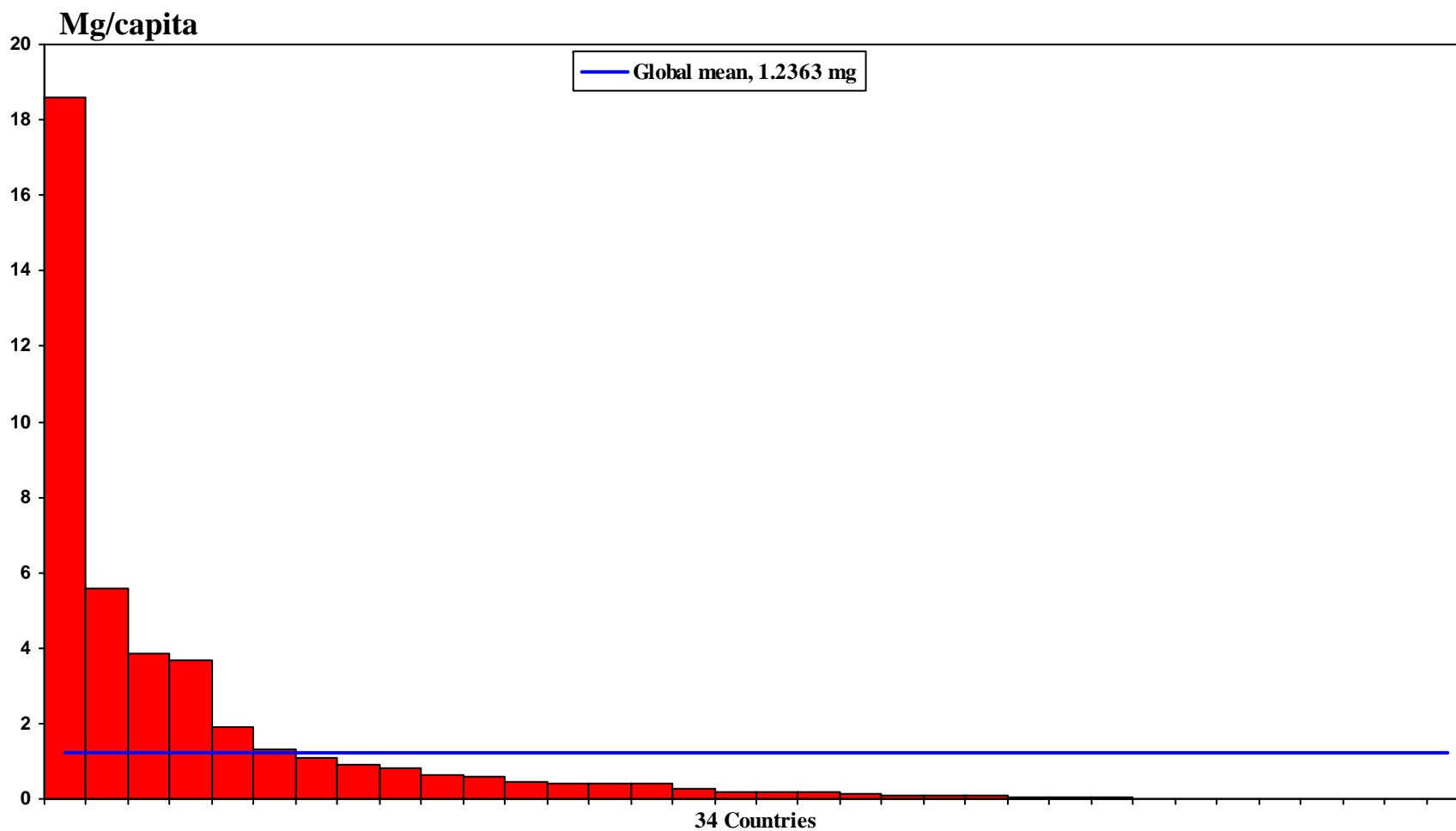

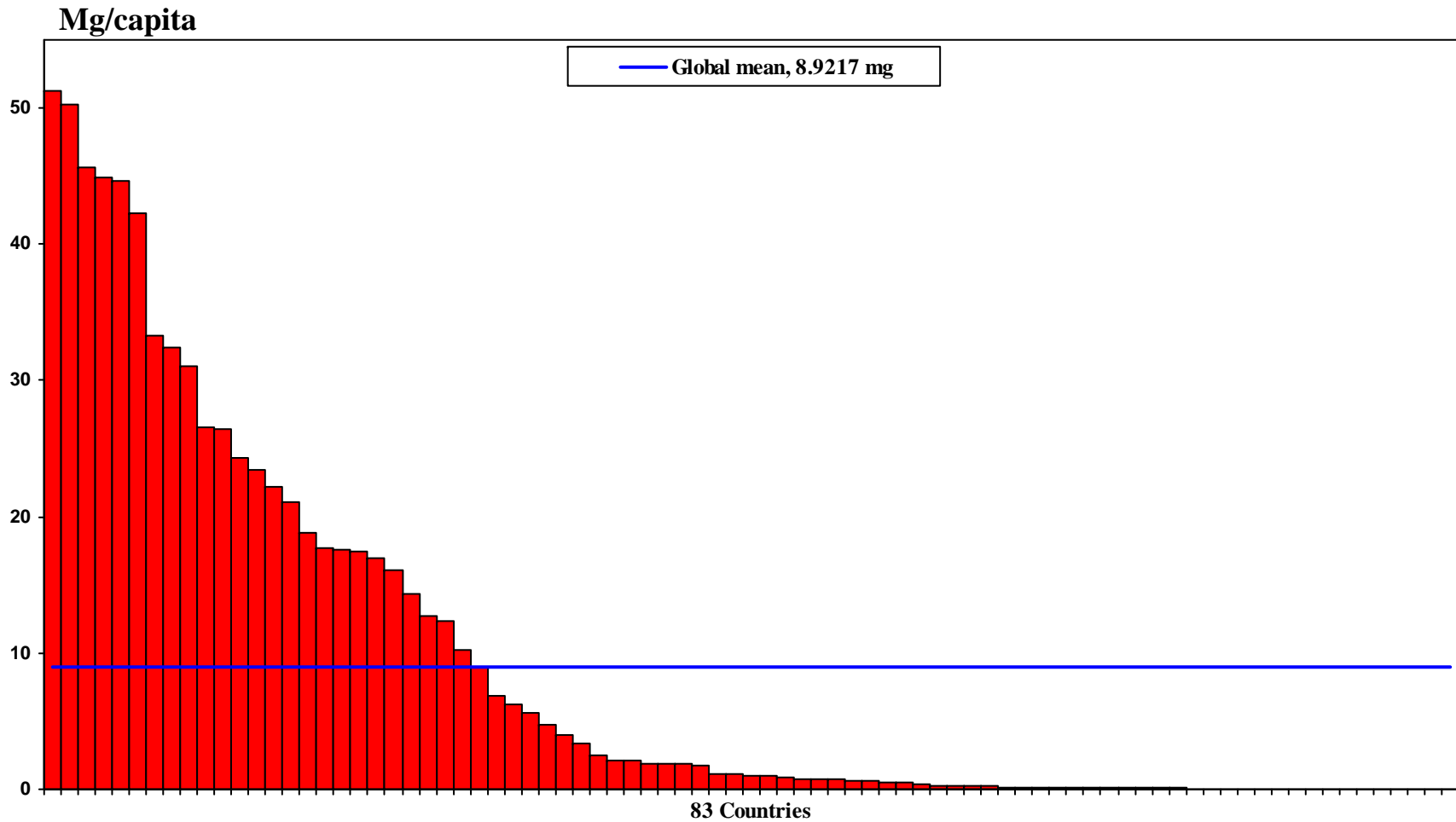

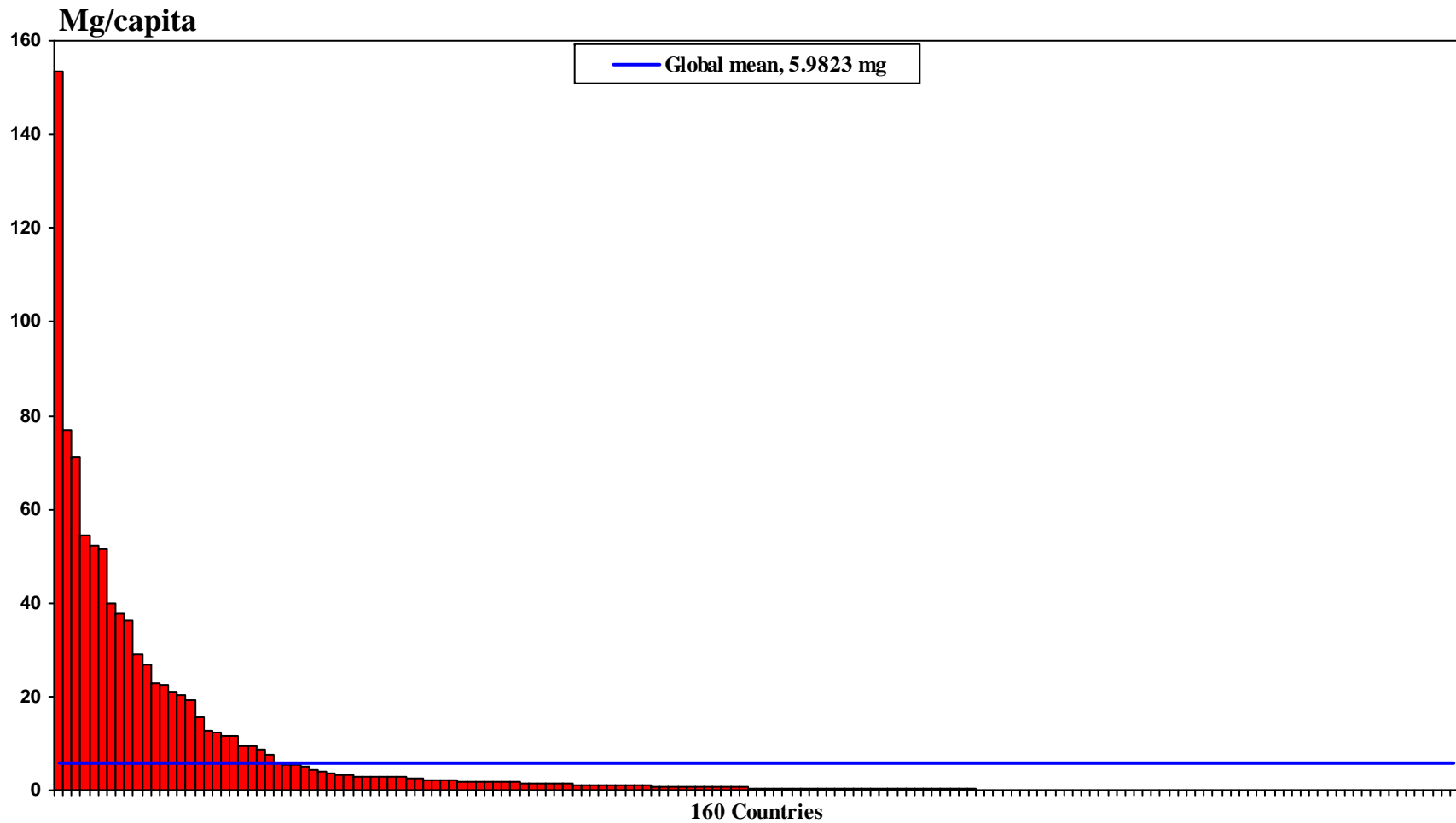

## Global Oxycodone Consumption, 2007: mg/capita

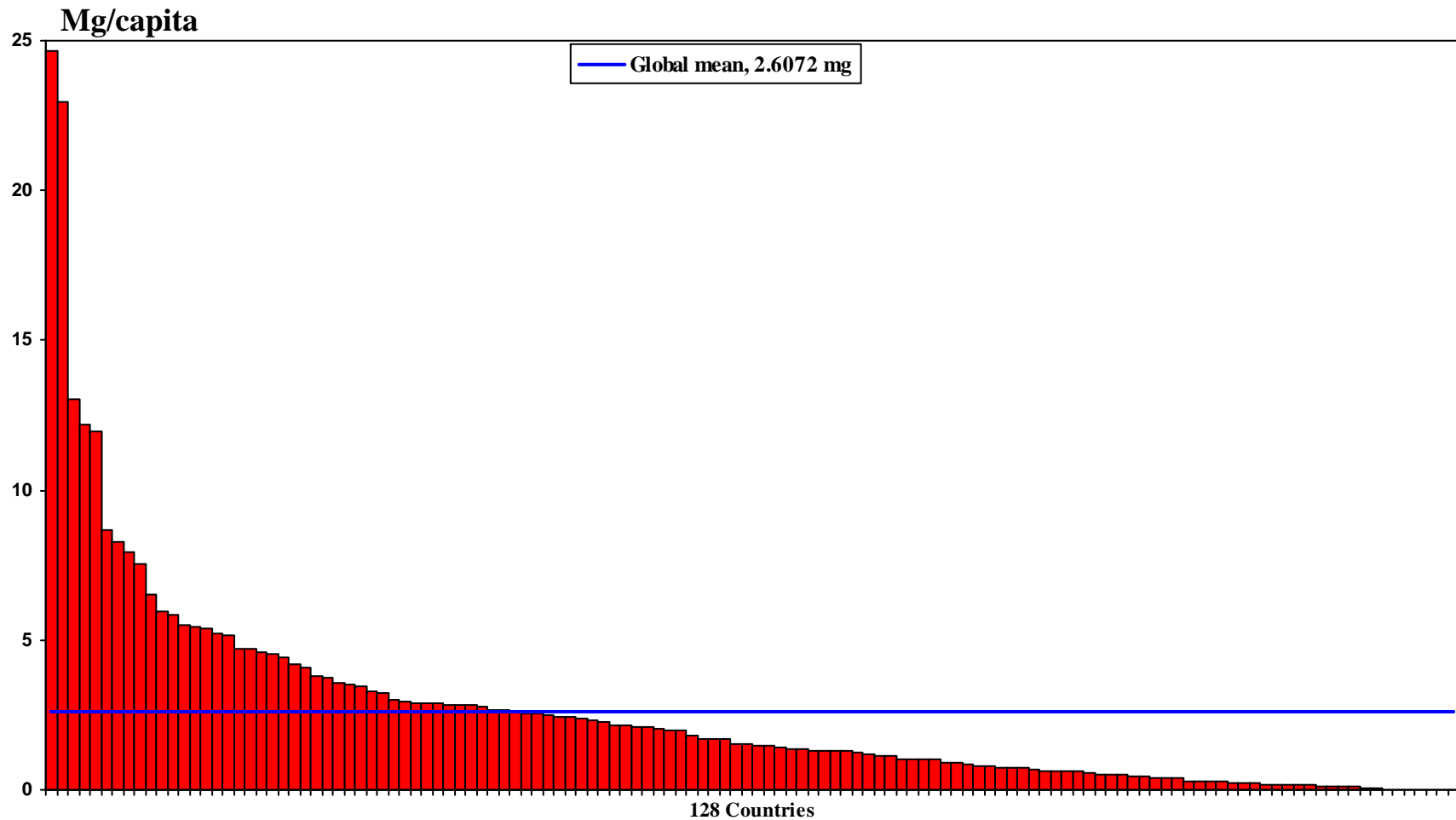
